To reserve your booth space for the 2026 National Convention, complete Exhibitor Application and pay online at <https://nafwb.org/exhibitors/>.

Exhibitor Booths are **\$600** per 10'x10' booth. Registering by **April 30** guarantees that your organization will be listed in the Convention Program. Booth spaces may be limited, so reserve yours soon. Applications will still be accepted after April 30 and booths will be assigned as space allows. Application and payment must both be received for registration to be considered complete.

You may indicate your booth space preferences on your application. Booths are assigned on a first-come basis. You may not receive your selected space(s), but every effort will be made to accommodate your choice.

A professional decorator will install each 10' deep x 10' wide booth. The rental fee includes the following:

1. One 2' x 8' x 30" skirted table.
2. Two chairs.
3. Identification sign (7" x 44", 2 lines).
4. 8' high backdrop with 3' high side drapes.
5. Wastebasket.

You will receive an email to access an online exhibitor kit from **Fern Expo Services** after the April 30 deadline. This kit includes pricing for equipment and furniture from the decorator and pricing for utility services (power, Internet, etc.) from the Greater Columbus Convention Center.

**FOOD/BEVERAGE SAMPLING POLICY:** Any exhibitor providing ANY food or non-alcoholic beverage item is required to notify Levy Restaurants in writing as to the nature of the proposed product giveaway. (See Exhibitor Sampling Guidelines [here](#).)

\*Exhibitors **wearing an exhibitor ribbon** will be allowed to enter the hall Tuesday and Wednesday morning at 9:30 a.m. Exhibits will be closed each evening from 6:30 p.m. – 8:30 p.m. for convention worship services. All exhibitors will be required to leave the exhibit hall from 6:45 – 8:15. Security will be present in the hall during this time. Exhibitors **wearing an exhibitor ribbon** will be allowed back in the hall at 8:15. **No one** (including volunteers) will be allowed entry into the hall before 8:30 without an exhibitor ribbon.

- **CLOSING PROCEDURE WEDNESDAY NIGHT:** The exhibit hall will close at 6:30 p.m. Wednesday evening for attendees, and exhibitors will be required to leave the hall at 6:45 for the evening service. *Only* exhibitors wearing an exhibitor ribbon will be allowed back in the hall **15 minutes after service has ended** for tear down and move out. **Any exhibitor** found tearing down their booth earlier than 6:30 or during service will jeopardize future opportunity to exhibit.
- Each exhibitor **must** also register as a convention attendee to obtain an official convention badge, which will be required to gain access to any convention venue. **This is a separate registration from the exhibition application.** Pre-registration opens April 1. You can pre-register online at [www.nafwb.org/convention](http://www.nafwb.org/convention).
- Convention housing opens **Monday, May 11**. Information will be available online at [www.nafwb.org/convention](http://www.nafwb.org/convention).
- Decorators will be available on-site during setup for any last-minute requests.
- You will be responsible to unload, set-up, operate, and dismantle your own exhibit materials.
